Welcome to Wildwood

You are about to enter a unique recreational area with a varied and distinctive history, a wide range of plant and animal life, and unusual geologic formations, and beauty to enthrall visitors of all ages. We sincerely hope that you enjoy your visit.

The Park is open to visitors daily from 7:00 A.M. to sunset, A.M. to 5:00 P.M., weekends from 8:30 A.M. to sunset, conditions permitting. Parking lots are open weekdays from 8:00 A.M. to 5:00 P.M., weekends from 8:30 A.M. to sunset.

Wildwood is rich in both historic and archaeological resources, which indicate that favorable environmental conditions have existed on the mesa and the canyon below for thousands of years. Scientific studies have revealed that seasonal hunting camps have long ago as 6000 B.C. Shell beads, arrowheads, basketry fragments and artifacts that favor the native American people and which indicate that favorable environmental conditions have existed on the mesa and the canyon below for thousands of years.

During the Spanish colonization of California, this land became a part of "Rancho el Conejo" which was granted to Ignacio Rodriguez in 1803.
